Without admitting any legal obligation, Goldman Sachs or another subsidiary of GS Group will remit appropriate profits, if any, to the Company.
- Goldman Sachs beneficially owns directly and GS Group may be deemed to beneficially own indirectly 449,622 Common Units and Goldman Sachs also had open short positions of 465,083 Common Units, reflecting changes due to exempt transactions.
