CROSSTEX DECLARES QUARTERLY DISTRIBUTION AND DIVIDEND

DALLAS, July 19, 2013 — The Crosstex Energy companies today announced the declaration of the quarterly distribution for Crosstex Energy, L.P. (NASDAQ: XTEX) (the Partnership) and the quarterly dividend for Crosstex Energy, Inc. (NASDAQ: XTXI) (the Corporation) from the second quarter of 2013:

- The quarterly distribution on the Partnership's common units will be \$0.33 per unit. The distribution is payable August 12 to unitholders of record July 30.
- The quarterly dividend on the Corporation's common stock will be \$0.12 per share. The dividend is payable August 14 to shareholders of record July 30.
