ENLINK MIDSTREAM DECLARES QUARTERLY DISTRIBUTIONS

DALLAS, JULY 25, 2014 — The EnLink Midstream companies today announced the declaration of the quarterly distributions for EnLink Midstream Partners, LP (NYSE: ENLK) (the Master Limited Partnership) and EnLink Midstream, LLC (NYSE: ENLC) (the General Partner) from the second quarter of 2014:

- The quarterly distribution on the Master Limited Partnership's common units will be \$0.365 per common unit. The distributions are payable on August 13 to unitholders of record on August 4.
- The quarterly distribution on the General Partner's common units will be \$0.22 per common unit. The distributions are payable on August 14 to unitholders of record on August 4.

EnLink Midstream is a leading midstream provider formed through the combination of Crosstex Energy and substantially all of the U.S. midstream assets of Devon Energy. EnLink Midstream is publicly traded through two entities: EnLink Midstream, LLC (NYSE: ENLC), the publicly traded general partner entity, and EnLink Midstream Partners, LP (NYSE: ENLK), the master limited partnership.

EnLink Midstream's assets are located in many of North America's premier oil and gas regions, including the Barnett Shale, Permian Basin, Cana-Woodford Shale, Arkoma-Woodford Shale, Eagle Ford Shale, Haynesville Shale, Gulf Coast region, Utica Shale and Marcellus Shale.
