This Amendment No. 3 ("Amendment No. 3") to Schedule 13D relates to the Common Units ("Common Units") of EnLink Midstream Partners LP, a Delaware limited partnership (formerly known as Crosstex Energy L.P.) (collectively, the "GSO Funds") sold 17,997,296 Common Units at a price to the underwriter of \$30.21 per Common Unit pursuant to an underwritten offering registered on the Issuer's registration statement on Form S-3 (File No. 333-194465) pursuant to an underwriting agreement, dated March 20, 2014, among the Issuer, the GSO Funds and Citigroup Global Markets Inc.

Item 5. Interest in Securities of the Issuer.
